1. SAFETY/CONVENIENCE

Included with (ZX2) driver and front passenger high-back bucket seats or (ZP6) 5-passenger Express Crew Van Package. Not available with (ZX1) driver only high-back bucket seat or (AJ3) driver-side only frontal air bag. Always use safety belts and the correct child restraints. Children are safer when properly secured in a rear seat in the appropriate child restraint. See the Owner's Manual for more information.
- b. Air bag deactivation switch, frontal, passenger-side - Always use safety belts and the correct child restraints. Children are safer when properly secured in a rear seat in the appropriate child restraint. See the Owner's Manual for more information.
- c. Air bags, driver and right-front passenger, seat-mounted side-impact and head curtain side-impact - Not available with (YF2) Ambulance Package. - e. Assist handles, driver and right-front passenger
- f. Audio system, AM/FM stereo with MP3 player, seek-and-scan, digital clock, TheftLock, random select, auxiliary jack and 2 front door speakers - Not available with (U2K) SiriusXM Satellite Radio.
- g. Cargo tie-downs, 6 D-ring attachments on cargo area floor - Not available with (YF2) Ambulance Package, (Y3H) Paratransit Package, (5L3) interior trim panel or (ZP6) 5-passenger Express Crew Van.
- h. Child seat anchors, all three passenger rear seats have four anchors and two tethers
 - i. Console, engine cover with open storage bin
 - j. Convenience Package, power windows and door locks - Includes power windows and (AU3) power door locks.
NOTE: Does not include (ATG) Remote Keyless Entry. (ATG) Remote Keyless Entry must be ordered separately.
- k. Cup holders, 3 on the engine console cover
 - l. Rear Vision Camera

- n. Driver Information Center, includes fuel range, average speed, oil life, tire pressure monitoring, fuel used, ice warning, engine hours, average fuel economy, tachometer, and maintenance reminders. Compass and outside temperature available if equipped.
- o. Door locks, power with lock-out protection - NOTE: Does not include (ATG) Remote Keyless Entry. (ATG) Remote Keyless Entry must be ordered separately.

- b. Visors, driver and front passenger, cloth, padded - Not available with (TR9) auxiliary lighting or (C69) rear air conditioning or (DAA) driver and front passenger vinyl visors or (DH6) driver and front passenger visors padded with cloth trim.
- c. Tow/haul mode selector, instrument panel-mounted
- d. Tire Pressure Monitoring System (does not apply to spare tire)
- e. Theft-deterrent system, vehicle, PASS-Key III
- f. Steering wheel, steel sleeve column with theft-deterrent locking feature, Black

- g. Seating, 12-passenger, (2-3-3-4 seating configuration), 4-passenger seat is a 50/50 split, 2-piece configuration
- h. Seats, front bucket with vinyl trim and head restraints, includes inboard armrests - Requires (**W) interior trim. When ordering a seating arrangement that includes rear seats, includes rear bench seats with vinyl trim. Head restraints are not available on rear bench seats.

- o. Instrumentation, analog with speedometer, odometer with trip odometer, fuel level, voltmeter, engine temperature and oil pressure
- p. Headliner, cloth, over driver and passenger
- q. Floor covering, full-length Black rubberized-vinyl - Not available with (RFM) rear floor covering delete, (PCH) Hotel Shuttle Package or (YF2) Ambulance Package.

- g. Glass, Solar-Ray deep-tinted (all windows except light-tinted glass on windshield and driver- and front passenger-side glass)

- i. Glass, swing-out side door windows
- j. Glass, full-body window package - Includes (A18) swing-out rear cargo door window glass and (A19) swing-out side door window glass.
